

Randy Samoff tabbed for 2010 Sonny DuBose Superintendent of the Year award

Terry Gill, past president of the South Texas Golf Course Superintendents Association and the winner of the inaugural STGCSA Sonny DuBose Superintendent of the Year award (for 2008), wrote in his letter nominating Randy Samoff for the 2010 award, "taking the course from a transition state back to Tour standards year after year is really remarkable."

He was speaking of the issues Samoff faces every year when he's preparing Redstone Golf Club's Tournament Course to host the Shell Houston Open. As

scheduling would have it, the Tour pros come to Houston just about the time of year when the area's courses are adjusting from ryegrass to Bermuda.

That's not easy an easy task, even if you're not attempting to match playing conditions similar to those found at Augusta National Golf Club, but somehow, Samoff manages to lead his team to success every year.

Given that (and more), it's fitting that Samoff was named the recipient of the 2010 Sonny DuBose Superintendent of the Year award. Formal presentation of the honor took place last month during the STGCSA's Christmas Party at BraeBurn Country Club.

The award was created by the STGCSA in 2008 to honor the memory of L.W. "Sonny" DuBose, who passed away on Dec. 11, 2007, and to recognize significant achievements and

contributions by an STGCSA member on an annual basis. DuBose was one of the founding members of the STGCSA, which was chartered in 1958.

"What an honor to be associated with Mr. DuBose," said Samoff of the credit, the only step of its sort taken by the STGCSA membership to officially credit one their fellows for outstanding efforts. "and the same can be said about Johnny Walker and Terry Gill. They've all done so much for our industry, profession and association."

Walker was the recipient of the 2009 Sonny DuBose Superintendent of the Year award.

"A couple of people had called me to make sure I was coming to the Christmas Party," Samoff added, "but I wasn't expecting to win. It was a real surprise."

An Abilene, Texas, native, Samoff's family relocated to the Houston area when he was just two years old and he's been in southeast Texas ever since—he considers Baytown his home town.

After graduating from Robert E. Lee High School in 1995, Samoff, now 33 years old, headed to Texas A&M University to study chemical engineering. Something about that just didn't quite fit, though, and after two years, he changed direction.

"I just wanted to be around sports, something in sports management," he explained. He earned a Bachelor of Science degree, majoring in kinesiology with a sports management specialization, in 1999.

Toward the end of his years at Texas A&M, he worked as an intern at The Woodlands Country Club. His duties were widely varied, but he

He received the STGCSEA's Distinguished Service Award in 1987.

Hess became a Certified Golf Course Superintendent in 1986 and has earned recertification five times. Of the 55 Master Greenkeepers in the world, only 20 have both the "CGCS" and "MG" designations— Alan Hess is one of them.

Hess is the father of STGCSEA member, Adam C. Hess, the 2010 GCSAA National Champion Golfer.

Out of Bounds: What are inert ingredients?

Sometimes we get so focused on the active ingredient that we forget up to 99 percent of a pesticide is actually an inert ingredient. Inert ingredients play an important role in product performance, ease of application, spreading/sticking, and shelf life.

A complete list of all inert ingredients approved for use by the EPA can be found at:

<http://www.epa.gov/opprd001/inerts/>.

Some interesting examples of inert ingredients I found on the EPA's "Inert Ingredients Permitted for Use In Nonfood Pesticide Products" list include vermiculite, sodium nitrate, avocado oil, castor oil, cardboard, cat food, beer, cheese and formaldehyde.

A manufacturer is not required to list an inert ingredient on a label unless it is classified as "highly toxic." Because these inert ingredients are not required to be listed, they are essentially "trade secrets."

These inert ingredients may provide a competitive advantage for one product over another even though the active ingredient content maybe identical. In other words, two pesticides may have the same percentage of a particular active ingredient but may have different very different inert ingredients.

The difference in inert ingredients may also explain why two products with the same active ingredients may carry different signal words or have different application site restrictions. A good example is RoundUp versus Rodeo.

Both products have the same active ingredient, but Rodeo is the glyphosate product approved for use near ponds. Essen-

tially, the inert ingredients in one product may be more toxic than another product. In the end, the "label is the law" and the label indications and safety information may be based on the active ingredient and inert ingredients.

spent about a quarter of this time working with the club's golf course maintenance staff.

"That," he said, "is where my love for the business started. That's where I had the most fun, but I knew I needed much more experience."

The Woodlands had hired him as an assistant club manager in 2001; he was still a jack-of-all-trades, but he was becoming more and more focused on the maintenance side of the equation.

In 2002, after discussions with then Director of Grounds Maintenance Tony Miller, Samoff made the move . . . he became a second assistant superintendent, assigned to The Woodlands' Palmer Course.

Then a new father with a new job, he knew going back to school for the knowledge and experience was not an option, so he enrolled in a Penn State University correspondence course, and in 2003, completed the program with a Certificate in Turfgrass Management.

He was promoted to assistant superintendent at The Woodlands' Oaks Course in July of that year. Just nine months later, he made another move, this time changing facilities altogether to become assistant superintendent at Redstone Golf Club's (then under construction Tournament Course).

Two steps remained before he would reach his current assignment as golf course superintendent for both of Redstone's courses.

The first happened in 2005, when he was promoted to head superintendent on the club's Tournament Course. The second happened in 2008, when then STGCSA President Roger Goettsch, Redstone's Director of Agronomy, left for another job in Austin.

Samoff was a natural fit, and Redstone's management interviewed a number of other qualified candidates, Samoff was put in charge of both of the club's courses. The reviews of his work have been nothing less than spectacular ever since, and his selection as the STGCSA's Superintendent of the Year award is simply his latest accolade.

"I'm very proud of the honor, but really, it's the entire team that makes things work," said Samoff. "We have great ownership at Redstone and a great staff, and I've worked to surround myself with good people."

"I've learned that you don't have success on your own," Samoff added. "Surrounding yourself with good people makes you a lot more successful."




