

There's an election coming!

There's an election or two coming up, just in case you need reminding. First up, of course, is the presidential election, on Tuesday, Nov. 4. That one will be sort of important, so here's hoping you take time to go vote.

And then there's the South Texas Golf Course Superintendents Association election, which will take place during the STGCSA Annual Meeting, Nov. 10 at The Houstonian Golf and Country Club.

Needless to say, it's an election that will be very important to the future of the Chapter.

Due to circumstances outside the organization, Russell Tippie has resigned his position on the Board of Directors with one year to go on his term. Wade Warms, CGCS, who has served on the Board for a number of years, is running for Secretary/Treasurer this time around, and three Board members—Bret Barclay, Chris Smith and Ed Schultheis—are cycling out after serving two-year terms.

That means there are a total of five Board positions to be determined, and that amounts to over half the membership on the Board of Directors. An important election, indeed.

Thankfully, those running for election this year are highly qualified to file the roles they seek. With Roger Goettsch, GGCS, moving into the Immediate Past President slot, sitting vice-president, Lee Gravett, is up for election as the STGC-SA's president for 2009.

Willy Plowman, who has served as Secretary/Treasurer for 2008, is a candidate for the 2009 vice-president position, and, as mentioned above, Wade Warms is on the ballot for Secretary/Treasurer responsibilities.

Four of the available Board positions will be filled by superintendents— Kevin Borowski, Steve Chernosky, Russell Birkhimer and Blayne Sparks have thrown their names into the hat for those stations.

Barring write-in candidates, three of those four will fill a trio of two-year terms. The fourth slot is for the remainder of Tippie's term and will be filled by whichever candidate receives the fewest votes in the election.

The fifth spot to be filled on the Board is a two-year Affiliate Member position, and there are, again, four qualified candidates on the ballot—Brandon Cole, Kyle Graham, Jeffrey Jowell, CGCS, and Brent Ratcliff.

A few biographical details and qualifications for the candidates are listed on the insert included with this issue of *Tee to Green*. Please take a few moments to review them so you'll be prepared to vote when the election arrives. Each of the candidates will, of

TCEQ waste disposal days

Every once in a while, you probably end up with a few leftover items that cannot be disposed of through your regular garbage collection service.

With that in mind, you should keep in mind the Agricultural Waste Pesticide Collection Program, part of the Texas Commission on Environmental Quality. The TCEQ is offering a series of collection days in October to help with your disposal needs.

One of those events, to be operated by County Extension Agent Brent Batchelor (979-245-4100, b-batchelor@tamu.edu) will take place from 8 a.m. to 1 p.m. on Oct. 28 at the Matagorda Country Fairgrounds in Bay City (400 West Fairgrounds Rd.).

The event is open to all Texas residents who apply pesticides or other agricultural chemicals for the production of agricultural products in Texas and who currently have banned or unwanted agricultural chemicals.

Products that can be disposed of at the gathering include most pesticides and herbicides, insecticides, fungicides, growth regulators, some containers, various mechanical fluids and lubricants and lead-acid batteries.

Materials not accepted include tires, fertilizers or nutrient materials that are neither hazardous nor contain pesticide admixtures and propane/butane gas cylinders larger than 20 gallons.

There is no cost for disposing of the accepted materials presented at the event.

If you cannot attend the Bay City event, there are two others that will take just outside the STGCSA boundaries (Oct. 23, Victoria Community Center, Victoria; Oct. 29, Fayette County Fairgrounds, La Grange).

Out of Bounds: Triploid Grass Carp for pond weed control

The triploid grass carp, Ctenopharyngodon idella, is a sterile vegetarian fish that can be used to control aquatic vegetation in ponds. The fish can only be used in areas where



they are unlikely to escape into public waters.

The use of this fish may be a cost effective alternative to chemical herbicides, but that will depend on the vegetation that needs to be managed. For example, grass carp will eat hydrilla (Hydrilla verticillata), muskgrass (Chara spp.), and pondweeds (Potamogetan spp.), but the fish are not an effective control for many types of filamentous algae.

The fish feed from the top down. Once all above ground plant tissue is consumed, the turbidity of the water may increase due the fish looking for organic matter to eat in the pond's sediments. An additional possible negative consequence of introducing grass carp is that if excessive amounts of vegetation are removed, some wildlife species maybe discouraged.

The suggested stocking rate is five per acre of water if less than 50 percent of the pond is covered by vegetation. Fish should be about 10-12 inches in length when introduced into the pond to avoid predation. For maximum effectiveness, a pond should be restocked every five to seven years. Younger fish are more active feeders. It is thought that most fish live at least 10 years.

Triploid grass carp are regulated by Texas Parks and Wildlife Department. Permits are obtained through the Inland Fisheries Division of Texas Parks and Wildlife. The application fee is \$15.00 plus \$2.00 for each fish you plan to purchase.

The fish can only be purchased from a Texas fish farmer that holds a valid exotic species permit. A list of permitted fish farmers will be provided with your approved permit.

In order to obtain a permit, you must be able to demonstrate that the fish will not escape. A Texas Parks and Wildlife official may need to visit your golf course to determine if there is a risk the fish may escape into public waters.
