Out of Bounds:

Tree installation and management on Houston golf courses

Having traveled around Houston visiting golf courses for the past three years, I have observed some similarities in tree management on golf courses in our region. In particular, the similarities are:

- Trees tend to be all of one age class at a particular location.

When large trees are present, typically they are over-mature. Because these trees are the same age, they will likely start to decline at the same time. Promoting diversity in age-class is an important principle in maintaining a consistent tree canopy in urban landscapes.

- When trees are planted on golf courses, I have noticed larger

plant material is preferentially installed. The trees are often placed as “islands” in a “sea” of turfgrass. Larger trees planted in open areas will have a longer establishment period and be more difficult to manage than if groupings of smaller trees are planted. For the price of a single 45-gallon container tree, dozens of small 1-gallon container trees can be purchased. In a commercial forestry setting, pencil-sized trees are planted close together with the expectation that some trees will be lost to drought, disease, insects or thinning. Wouldn't you rather mow around a few large tree groupings than dozens of little islands scattered all over the place?

- Tree species diversity seems to be minimal on most golf

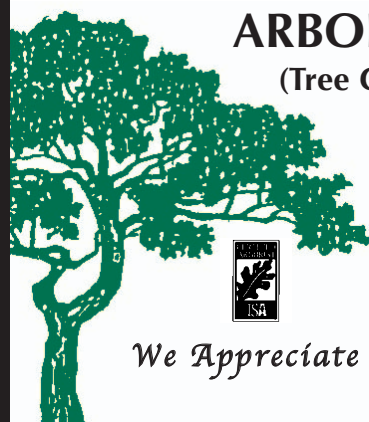

courses. Having only a few species of trees on your course increases the possibility that a single event could greatly reduce your “forest.” Just like turfgrass monocultures, tree monocultures promote insect and disease outbreaks. In addition, having a diversity of trees will encourage more types of wildlife. In past articles I have mentioned many tree species that could be utilized, including species that are small in size.

• Planting occurs year round. The best time to plant woody plant material is during the fall, when soils are warm, air temperatures are lower, and rainfall is more likely. Roots will continue to grow through the winter giving your tree a 6-month head start on the hot dry conditions of Texas summers.

The next time it is decided your course needs more trees, make an inventory of what you already have. Make notes of the various tree species, their relative ages and their placement. In general it is more efficient and less costly to plant trees when they are small, in groups, and to have a diversity of species at your facility.

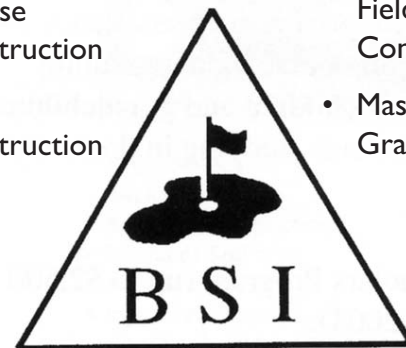
