## Two special meetings coming up in October

It may seem like the year is winding down, but don't think that means there isn't plenty to do.

There are two "special" meetings coming up in October, one directly related to the mission of growing better turfgrass and one focused on golf courses as a key component to environmental quality.

Both gatherings are being presented by the Texas AgriLife Extension Service and the STGCSA is a supporting partner in both projects. Additional details about both can be found below, so have a read and mark your calendars accordingly.

### 2010 Turfgrass Disease Clinic & Field Day

The Texas AgriLife Extension Service will conduct its 2010 Turfgrass Disease Day on two dates and two locations this time around.

Royal Oaks Country Club will host the first day's activities on Oct. 18 from 11:30 a.m. to 3 p.m. MurffTurf Farms (in Crosby) will host the second day's gathering on Oct. 20, also from 11:30 a.m. to 3 p.m.

The subject of the Royal Oaks get together will be "Athletic Turf Management," different aspects of which will be addressed in a half-dozen presentations. The focus on the second day, which will also include six different seminars, will be "Sod Production & St. Augustine Management."

As always, Texas Department of Agriculture Pesticide Application and GCSAA Continuing Education Unit credits will be available to those attending.

The cost of attending is \$40 (including lunch) for those who pre-register online and includes lunch. Pre-registration information

You may also choose to register on-site for a cost of \$60.

### 2010 Environmental Golf Course Management Field Day

The Club at Falcon Point is hosting the Texas AgriLife Extension Service's 2010 Environmental Golf Course Management Field Day on Oct. 26 from 7:30 a.m. through 3:15 p.m.

Texas Parks & Wildlife and Audubon International are supporting partners for the meeting, which will focus on the role of golf courses in a healthy environment and will include presentations about enrolling your facility in Audubon International's Cooperative Sanctuaries Program for Golf Courses (ASCP).

A tour of Falcon Point will highlight various aspects of attaining ACSP certification and management, including pond bank stabilization, birdhouses, the use of grass carp for pond weed management and equipment cleaning and disposal areas.

The cost of attending is \$75, including lunch—GCSAA Continuing Education Units will be available for those in attendance.

## Out of Bounds: Enhance wildlife with birdhouses

Golfing is an outdoor experience enjoyed by many in this country. Golf courses provide a great place for the general public to exercise, socialize and escape from the built environment.

The fact is, however, that most people are not sportsmen, nature enthusiasts or employed in a field that necessitates interaction with plants and wildlife. The vegetation, lakes and wildlife witnessed during a golf outing increase the value of the sport and may be a golfer's only regular outdoor experience.

A simple and inexpensive way to increase desirable wildlife on the golf course and your golfers' experiences is to add birdhouses around your facility. In addition to increasing the wildlife value of a course, birds also reduce insect and rodent populations.

Birdhouse dimensions, location and building materials can all influence their effectiveness. The following lists pointers to ensure success in building and installing birdhouses:

- Build and install birdhouses before nesting season.
- Wood is the best material for construction (often scrap pieces are sufficient in size).
- Consider using rot-resistant building material (e.g., cedar, cypress or redwood).
- Do not use metal, as that will increase temperatures inside the birdhouse, often killing eggs and young.
- Drill ventilation holes into the side of the birdhouse below the roof overhang.
- Do not paint the inside or face of birdhouses.
- If a birdhouse is going to be placed in an exposed area, consider painting the outside white to reflect light and discourage heat buildup.
- Birdhouses placed in less exposed areas do not need to be painted or should only be painted subdued colors like brown or dark green.
- Birds can be territorial, so birdhouses should not be placed close together.
- Check birdhouse boxes each spring before nesting season to remove wasps, bees, rodents or old nesting materials. Bird boxes should also be cleaned out after nesting season is completed to remove any potential parasites and make room for the next occupants.

With small and directed enhancements to promote wildlife, the golfing experience can be made more valuable to golfers.

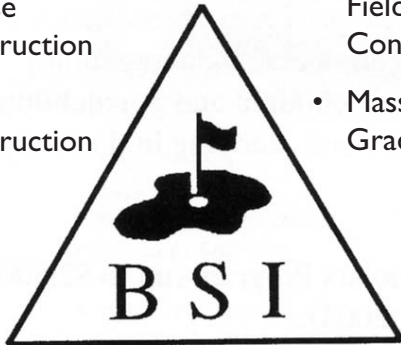

## Unwanted pesticides?

If you've got unwanted pesticides or other agricultural chemicals cluttering up your facility and don't know what to do with them, here's your chance—the Texas Commission on Environmental Quality is conducting a series of free collection events around Texas this fall, and two of them will take place within the STGCSA's geographical territory.

The first of those will take place Oct. 5 in Chambers County at Whites Memorial Park (295 Whites Memorial Park Dr., Anahuac, TX 77514), from 8 a.m. to 1 p.m. The second will be held in Fort Bend County at the Needville Youth Fairgrounds (13631 Highway 36, Needville, TX 77461), also from 8 a.m. to 1 p.m.

Both events are available to Texas residents who apply pesticides or other agricultural chemicals for the production of agricultural products and, obviously, have banned or unwanted agricultural chemicals that need proper disposal.

The list of materials that can be delivered for disposal includes pesticides, herbicides, fungicides, gasoline and diesel fuel, transmission, brake and power-steering fluid, anti-freeze, lead-acid batteries, and oil, oil filters and grease.

Waste from chemical dealers, distributors or manufacturers will not be accepted.

If you have quantities larger than a pickup truck load, please call 512-239-3143 or your county agent for handling information.
